#### **1. Approval of Purchase Orders**

Motion to approve of Purchase Orders exceeding \$15,000.00 as recommended by Cory Wm. Wright, Township Administrator.

#### **2. Collective Bargaining Agreement Ratification**

Motion to approve the general terms set forth within a signed Tentative Agreement to modify the Collective Bargaining Agreement between the Union Township Police Association Communications (Dispatchers/Clerks) Division and the Board of Trustees of Union Township with an effective date of November 1, 2025 through October 1, 2028, with wages approved and stated therein effective through March 11, 2029, and further authorizing the Board to ratify and execute the final contract documents once all agreed modifications are incorporated therein. This approval and ratification shall specifically be applicable to the Union Township Police Association Communications (Dispatchers/Clerks) Division.

#### **3. ODOT Systemic Safety Sidewalk Grant – Old State Route 74 (Schoolhouse to Dogwood) Sidewalk**

Motion to authorize the Township Administrator to execute a consultant contract with TEC Engineering, Inc. for design and engineering work, and a corresponding Local Public Agency (LPA) ODOT-Let Project Agreement with the State of Ohio Department of Transportation in furtherance of the Old State Route 74 (Schoolhouse Road to Dogwood Drive – PID 124595) ODOT Systemic Safety Sidewalk Grant Project.

#### **4. ODOT Excess Land Contract Authorization**

Motion to authorize the Township Administrator to execute and enter into an agreement to purchase excess land currently titled to the Ohio Department of Transportation, located along Clepper Lane, for an appraised contract price of \$432,000.00, and authorizing all other measures or actions relative thereto in furtherance of the same.

#### **5. Property, Casualty & Liability Insurance Renewal: 2026-2027**

Motion to authorize the Township Administrator to execute and enter into an agreement to bind coverage with Hylant Group and the Ohio Plan to renew the Township's primary property, casualty, liability and all-perils insurance coverage for the 2026-2027 Calendar Year, in an amount not to exceed \$350,000.00 for the policy year.

#### **6. Union Township Cyber Coverage and Social Engineering Fraud Excess Insurance Coverage**
