

RESOLUTION 2010-08

The Board of Trustees of Union Township, Clermont County, Ohio met in regular session at the Union Township Civic Center on March 11, 2010 with the following members present: Timothy Donnellon, Matthew Beamer, Robert McGee.

MR. BEAMER made a motion to adopt the following Resolution:

RESOLUTION DECLARING SUPPORT AND PARTNERSHIP WITH THE 2010 U.S. CENSUS

WHEREAS, the U.S. Census Bureau is required by the Constitution of the United States of America to conduct a count of the population and provide a historic opportunity to help shape the foundation of our society and place an active role in American Democracy; and

WHEREAS, an accurate census count is vital to our community as census data is used to make vital decisions including redistricting and the allocation of federal funding; and

WHEREAS, one of the major goals of the 2010 Census is to increase the national mail back response rate, which not only reduces the overall cost of the census, but also increases the accuracy of the data;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Union Township, Clermont County, Ohio do hereby declare support of and partnership with the 2010 Census and encourage all residents of Union Township to participate in the constitutionally mandated census and to play a role in increasing participation among all members of our community so that the 2010 Census will be an accurate reflection of those living within Union Township.

BE IT FURTHER RESOLVED that this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.


BE IT FURTHER RESOLVED that this Resolution shall take effect at the earliest period allowed by law.
