

Ohio Women, Infants, and Children (WIC):

WIC helps eligible pregnant and breastfeeding women, women who recently had a baby, infants, and children up to 5 years of age. WIC provides nutrition education, breastfeeding education and support; supplemental, highly nutritious foods, and iron-fortified infant formula; and referral to prenatal and pediatric health care and other maternal and child health and human services programs.

If you change your mind

If either parent changes their mind and wishes to get their newborn back, the parent will need to go to the local public children services agency in the county where the newborn was left. The parent will be asked to complete a DNA test to prove maternity or paternity and this may be at cost to the parent.

Medicaid Benefits

24/7 Breastfeeding Hotline:

The Appalachian Breastfeeding Network operates Ohio's 24/7 Breastfeeding Support Hotline through the Ohio Department of Health. It is available all day, every day, including weekends and holidays and is operated by live, trained lactation professionals. This service is provided free of charge to all callers, including mothers, their families and partners, expectant parents, and healthcare providers.

Help Me Grow

Help Me Grow is a system of supports for pregnant women, caregivers with new babies, and families with young children with developmental delays and disabilities. Services are provided through Home Visiting and Early Intervention. More information at helpmegrow.org.

Cash Assistance

Ohio Works First (OWF) provides cash benefits to needy families for up to 36 months. Lower income families may be eligible to receive monthly cash assistance. For more information: bit.ly/3IjpPWp.

Adoption

Making an adoption plan means placing your child for adoption with another family. Your child may be placed with a relative, a friend, or someone who is working with an adoption agency or attorney. Placing a child for adoption is permanent, and once the decision is made, it cannot be changed. Before you make this important decision, you must talk to an assessor.

Safe Havens

Safe Havens were established in 2001 and allow a parent to leave a newborn infant (up to 30 days old) with:

- a medical worker in a hospital;
- a medical worker at a fire department or other emergency service organization; or
- a peace officer at a law enforcement agency.

If the newborn is left with a person at one of these places, and has not been abused or neglected, the parent will face no legal consequences for making this choice.

Who can take a newborn to a Safe Haven

The parent (mother or father) can take a child to a Safe Haven. The law provides protection from prosecution only for the newborn's parents.

Does the parent have to call before taking a newborn to a Safe Haven?

No. A parent may take a newborn to a Safe Haven at any time until the newborn is 30 days old.

What information will the parent have to provide?

The parent is not required to provide any information, including his or her name. However, it would help the newborn if the parent chose to provide basic health information. The parent will be offered a form to guide them in providing the most important health information:

What happens next?

If the newborn needs medical attention, it will be provided. The professional staff person who accepts the newborn will contact the county children services agency, which will work to find the child a permanent home. There are many families who want to adopt a baby.

When a parent cannot care for a newborn, leaving the baby at a Safe Haven may be the best choice for the child. If the parent is not sure about this decision, an adoption social worker can help by providing information on available options and services for parents and their babies.
